

COME VISIT MY DOMINICAN REPUBLIC CONTEST RULES

COME VISIT MY DOMINICAN REPUBLIC CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN AND PROVINCIAL LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY

- a. To be eligible for the contest, entrants must be legal residents of Ontario and 18 years of age or older at the time of entry;
 - b. Participants must be legally able to travel to the Dominican Republic (the "Destination") and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel;
 - c. Are excluded from the contest all employees, agents and representatives of the Ministry of Tourism of the Dominican Republic, namely the Organizer of the contest, its publicity and promotional agents, prize suppliers, material and service providers in relation to the contest, immediate family members, legal spouses, common-law partners, and all other persons that share a residence with any of the aforementioned excluded persons.
- 1.1 The Organizer shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Organizer for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Organizer reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD

The Contest is organized by the Ministry of Tourism of the Dominican Republic through its representative agency Latin Affaires Inc. (the Organizer). The Contest begins on or about Sunday, January 19, 2020 at 9:00 a.m. and ends on or about Saturday, March 28, 2020 at 11:59 p.m. (Contest period), after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER

3.1 No purchase is necessary to enter or win. To enter the contest, participants are required to watch the television series "**COME VISIT MY DOMINICAN REPUBLIC**", broadcasted at **City TV** starting on a date anticipated to be Sunday, January 19, 2020 at

9:00 a.m. and every Sunday at the same time from there on until March 22, 2020, or alternatively, watch the episodes on the contest website <http://www.comevisitmy-dr.ca>. During the episode, contestants must spot the thumbnail with the clue of the week, and enter it into the participation form. In order to validate their participation in the contest, each contestant must fill out the participation form in its entirety, available at <http://www.comevisitmy-dr.ca>, indicating: full name, telephone number, email address, city and province of primary residence, as well as the weekly clue, and accept the Contest Rules.

3.2 Limit of one unique participation per contestant per week: each contestant can only submit one (1) answer per episode during the contest period. To qualify, candidates must fill out the participation form in its entirety, between the day the episode is broadcasted each week on Sundays at 9:00 a.m. and the next Saturday immediately following at 11:59 p.m.

3.3 All entries become the sole property of the Organizer and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.

3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Organizers with proof that they are the authorized account holder of the e-mail address associated with their entry.

3.5 Any person that participates or attempts to participate in the contest more than once per week, or uses automated, mechanical, robotic, electronic or other non authorized entry method contrary to the present rules, will be automatically disqualified.

4. ABOUT "COME VISIT MY DOMINICAN REPUBLIC" TV-SERIES

"COME VISIT MY DOMINICAN REPUBLIC" is a new way to discover the Dominican Republic through the eyes of its people. In a 10-episode miniseries, Dominicans from all over the country will introduce you to their region through its history, its architecture, its music and local wonders. Watch a baseball game in Santiago, dance merengue to the rhythm and music of the Bonye group in Santo Domingo, explore the mountains of Jarabacoa, or swim in the blue waters of a subterranean lake. All this and more in "**COME VISIT MY DOMINICAN REPUBLIC.**" This TV series will be broadcasted on **City TV** for the first time at a

date anticipated to be Sunday, January 19, 2020 at 9:00 a.m. and every Sunday at the same time from there on until March 22, 2020.

5. PRIZE CONDITIONS

5.1 Participants could win one of two (2) grand prizes, each including a vacation package for two (2) persons for seven (7) night accommodation at the Senator Puerto Plata Spa Resort in Puerto Plata, courtesy of Air Transat. The approximate retail of the value of each prize is \$4,500 (not including taxes).

5.2 Each Grand Prize includes:

- Round-trip Economy flight on Air Transat with departure from one of the Canadian cities flying to Puerto Plata, served by the airline according to the flight schedule.
- Shuttle bus between the airport in Puerto Plata and the resort for two (2) persons.
- One (1) week, seven (7) nights accommodation for two (2) person in a double room (standard room), all-inclusive formula at the Senator Puerto Plata Spa Resort.
- Breakfast, lunch and dinner buffet, unlimited "à la carte" dinners (prior reservations may be required), local drinks and select international drinks on demand 24 hours, daily activities and sports programs, and evening entertainment.
- Taxes, airport fees, customs duties, entrance fees, tourist card and surcharges are all included in the prize.

5.3 Each prize includes all of which has been specifically described above and no other allowance will be granted. The Winner and Guest will be responsible for, but not limited to, the following expenses:

- Transport, notably from the Winner's residence to the airport;
- in-flight meals;
- headphones;
- In-flight entertainment;
- optional seating choice;
- additional fees;
- registered luggage fees;

- local and long-distance phone calls;

5.4 The prize cannot be used for any air miles plan or any other loyalty plan. The winner's flight date is subject to availability and the blackout dates indicated below.

5.5 The reservations are subject to free allocation and may not be available even if the date of the flights is available on the Air Transat website or through another travel partner.

5.6 The Winner and Guest must travel together on the inbound and outbound flights. Travel is valid from April 14, 2020 to February 21, 2021. Reservations must be booked by November 30, 2020 & subject to availability. Travel must be taken in the time period specified and cannot be extended beyond that date. Standard black-out dates apply such as Christmas and New Year's: from December 14, 2020 to January 03, 2021.

5.7 In the event that the Winner and / or the Guest are not available during the period indicated, the prize will be cancelled without any form of compensation and a new draw will be done. The Winner and the Guest, if any, will require a valid passport, at their expense, for the duration of their stay and/or all other travel documents required. In the event that the Winner and the Guest cannot travel because they do not possess the necessary documents, the prize will be cancelled without any form of compensation and a new draw will be made. The winner may be required to present a valid credit card at the hotel to cover incidental charges.

5.8 Arrangements concerning the booking of the travel package must be done at least 30 days prior to the departure date, at the latest on November 30, 2020, and are subject to the availability of the airline and the hotel.

5.9 All reservations are subject to 100% cancellation penalties. Once the reservation is confirmed, no changes can be made to the name of the passengers and/or the departure date. The booking is subject to the availability of the airline and hotel at the moment of booking. Terms and conditions of the airline and the hotel are applicable.

5.10 Without limiting its generality, all the following conditions apply to the prize: (i) The prize must be accepted as awarded and may not be assigned, transferred or converted into cash (no substitutions, transfers, unless authorized by the Organizer at their sole discretion); (ii) the Organizer reserves the right to substitute the prize or any of its parts, for any reason, for a prize or any of its parts of equal or greater value, including but not limited to and at its sole discretion, a cash prize; (iii) After having been declared the winner by the Organizer, the Winner will be contacted by the Organizer to receive the prize; (iv) the prize will be awarded among eligible contestants who have completed all the fields required on the contest form, namely: first and last name, telephone number, e-mail address, city and province of main residence, and weekly clue, as well as having accepted the Contest Rules. The winner is required to answer a math skill-testing question correctly and without additional help.

6. WINNER SELECTION OF ONE OF THE TWO PRIZES

7. THE DRAWS

7.1 GRAND PRIZE 1 OF 2.

The draw for the first grand prize will take place at the premises of Pub Interactive, located at Boucherville, Quebec on Monday, 24 February 2020 at 12 p.m. A representative of the Organizer will do the random draw among all entries corresponding to shows 1,2,3,4 and 5 received by the server hosting the competition, between Sunday, January 19, 2020 and Saturday, February 22, 2020. If it is impossible to contact the selected contestant within the five (5) business days of the draw, the Organizer reserves the right, at its sole discretion, to randomly select a new Winner. The first contestant selected at random during the first draw will be declared the first winner of the contest, subject to meeting all the conditions described in these rules.

7.2 GRAND PRIZE 2 OF 2.

The draw for the second grand prize will take place at the premises of Pub Interactive, located at Boucherville, Quebec on Monday, 30 March 2020 at 12:00 p.m. A representative of the Organizer will do the random draw among all entries corresponding to shows 6,7,8,9 and 10 received by the server hosting the competition between Sunday, 23 February 2020 and Saturday, March 28 2020. If it is impossible to contact the selected contestant within the five (5) business days of the draw, the Organizer reserves the right, at their sole discretion, to randomly select a new Winner. The first contestant selected at random

during the second draw will be declared the second winner of the contest, subject to meeting all the conditions described in these rules.

7.3 THE SELECTED ENTRANT OF THE FIRST PRIZE WILL BE NOTIFIED BY E-MAIL NO LATER THAN MONDAY 2 MARCH AT 5:00 P.M, AND THE SELECTED ENTRANT OF THE SECOND PRIZE WILL BE NOTIFIED BY E-MAIL NO LATER THAN MONDAY 6 APRIL 5:00 P.M.

8. GENERAL CONDITIONS

8.1 Personal information: personal information provided by contestants, including their name and contact information, is collected solely for the purpose of administering the contest and will not serve any other purpose without their consent. No communication, commercial or otherwise, unrelated to the contest, will be sent to the contestant by the Organizer, unless otherwise consented by the contestant, if applicable, by checking the appropriate box on the official contest form or as permitted under the Privacy Policy. Notwithstanding the foregoing, by entering the contest, all contestants accept that the contest Organizer may communicate with any winner through Facebook private messaging (Facebook Messenger), e-mail, or telephone call in order to inform them that they have won one of the prizes.

8.2 By checking the appropriate box on the official contest form, participants consent to the use of their personal information provided for the purposes indicated: receiving newsletter and practical information from the Ministry of Tourism of the Dominican Republic. 8.3 Refusal to accept the prize releases the Organizer from any obligation towards the Winner.

9. INDEMNIFICATION BY ENTRANT

Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.

10.1 The Organizer assumes no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Organizer are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Organizer assumes no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Organizer, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsite.
